

Transact and Win Promotion Terms and Conditions

1. The transact and win promotion will run from 24 April 2023 to 31 May 2023.
2. The Promotion is open to CABS new and existing customers over the age of 18 years. If an entrant below the age of 18 wins a Prize, he or she will be disqualified, and the Prize will be reallocated.
3. The qualifying criteria for participants shall be as follows:

3.1 Third and General Prizes Category:

- a. To stand a chance to win a Prize in this category, Customers must purchase airtime worth at least ZWL1,000 OR perform a ZIPIT transaction of at least ZWL25,000.
 - 1 X Dinner voucher at a luxury restaurant (e.g., Organikks) valued at USD200.
 - 10 X Grocery vouchers valued at USD 50 each.
 - 50 X Airtime vouchers valued at USD10 each.

3.2 Second Prize Category

To stand a chance to win a Prize in this category, Customers must:

- a. Perform a minimum of 3 airtime transactions with a minimum transaction value of ZWL2,000
- b. Perform a minimum of 2 ZIPIT transactions with a minimum transaction value of ZWL30,000
 - 2 x Local destination Weekend holiday trip valued at USD750 each (e.g., Nyanga, Great Zimbabwe as per winners' location)

3.3 First Prize Category

To stand a chance to win the first Prize, Customers must:

- a. Perform a minimum of 5 airtime transactions with a minimum transaction value of ZWL2,000
 - b. Perform a minimum of 3 ZIPIT transactions with a minimum transaction value of ZWL50,000
 - 5 x Solar kits valued at USD1000 each.
4. A random electronic draw shall be conducted at the end of the promotion period.
 5. Winners will be announced at the end of the promotion period and prizes disbursed within the month of June 2023.
 6. There shall be 68 winners for this promotion, drawn across the different Prizes Categories
 7. Only one prize will be awarded per participant during the Transact and Win Promotion. If a participant's name is selected for a second time, it will be disregarded, and the prize will be reallocated.
